 - Grating, rock, and slab are complete. The Yaupon Holly was accidentally taken out and we are working with them to get it replaced. We have spent \$22k on the first phase of the project. It is more than we anticipated due to rising costs of materials. For example, when we started the project cement was \$90 to \$100/yard. Now it's \$140/yd, gravel was \$30/yd and now it's \$80/yd.
 - We will need donations to continue the project. We are working on how we can best go about doing this according to the by laws.
 - Phase II and Phase III are left. If we can get the project done in two phases, we will but it comes down to funding. We are working on options 1 and option 2 If we can only have one thing then we want this. If we can do two things, then we want to do this.

 - 2. Sprinkler system

May revisit this idea when our machine stops working. We are working on getting bids to relocate the compressor to the roof. This will help our AC in during events.
