- I. Call to Order 6:30pm

- III. Roll call of Directors, Proof of Quorum
 - A. **Present**: David Riley, Bryan Gaddis, Judy Laney, Ashley Hougland, Clay Fowler, and Marianna Willingham.
 - B. Absent: LaRue Hand
- IV. Proof of notice of meeting
- V. Approval of minutes of preceding meeting
 - A. Clay motioned
 - B. Bryan seconded
 - C. The remaining board members present voted to approve the minutes.
- VI. Report of Officers

A. President's Report

- 1. David motioned to vote to approve purchase of a new PA system \$2500, blue tooth compatible for hearing impaired as well as additional speakers if we ever need to add to the system.
 - a) Judy moved to approve
 - b) Bryan second
 - c) The remaining board members voted to approve the expense for the PA system.
- 2. Status of Brookhollow pump and repairs
 - a) POA is responsible for pumping water up brookhollow.
 - b) A little stream of water is being pumped up to the top pond by the Chapel through a 2" pipe. We will add lime to the pipe to try and clean it out so that water flows better.
 - c) Pipe that drains brookhollow into the lake from under the road will need to be cleaned out. It's stopped up and will need to be roto-rooted to clean the pipe out. Cory Needham with the City has offered to help.
 - d) We need to replace the current pump with a more adequate pump a 10 horsepower pump would pump 150 gallons a minute. It's compatible with the electricity that is already there.
 - e) The cost of the pump is \$2500. Installation may be another \$1500 this would include putting in a large pipe to put the pump down

- into. This will mitigate the pump from debris. Also, add a cage around the pump to prevent tampering.
- f) Installation is volunteer hours from neighbors. Greg Biram, a neighbor, has offered to help David Riley install the new pump.
- g) Cattails get in the pump and they have to be cleaned out every other month.
- h) Board vote to approve the replacement of the pump and installation
 - (1) Marianna motioned to approve
 - (2) Bryan seconded
 - (3) The remaining board members voted to approve the expense.
- 3. Boat Dock if a resident wants to add bumpers to their slip they are able to do so at their expense. Residents can improve their slips at their own expenses.
 - a) Vote to approve lease agreement for boat slip rentals
 - b) The board agreed to table the approval of the lease and will further discuss the boat slip lease agreement.
- 4. Rock Garden maintenance
 - a) Ashton Walden \$875/yr
 - (1) Ground sterilizer and weed spraying
 - b) Get a quote for maintenance from Travis to do regular maintenance. Travis can only do maintenance. He doesn't have licensing to spray.

 - c) Judy found that the City was charging the POA for sewage and garbage pick up on the Rock Garden. The City refunded us for this year's charges. So what we will be saving on that will go toward improving and maintaining the rock garden. and the savings from

 - b) Currently postage would, at minimum, cost us around \$415 per mailing. When we get the nonprofit status back that cost will substantially decrease.
 - c) This is a very big monthly or quarterly expense for the POA. Not enough advertising could be sold to cover this expense.
 - d) We will mail out an annual print in March which will include a ballot.
