I. Call to order

III. Approval of minutes from last meeting

IV. Open issues

- a) Review of Financial Position and report/Potential COVID Funds for revenue loss review submittal.
 - (a) Lot property dues are behind on 320 Lots
 - (b) \$3500 in rentals per month to catch up on venue rentals for 2020
 - (c) Repairs and maintenance with dock included we are over budget but without it we are under budget. Dock is considered Capital Improvement Expense.
 - (d) Lifeguard expenses are more this year because of COVID-we were open an extra day
 - (e) Our cash has gone down because of revenue, taxes, payroll, and regular expenses. We should see some grant revenue through the city. Property dues and venue rentals are needed. The city is going to submit the grants for us. We will see what will come through. 70% on the dollar. Maybe 21k.
- b) Former Real-estate office updates and discussion decision on disposition/maintenance. Status of Vote.

- (2) Vance has had some contractors coming into quote. Zero landscape and two planter boxes with drip and crushed granite pathways. Space will be left for waterfall. We are at least 90 days out. Carter also is working on a bid.

 - (1) Pool activity Monica Nowlin
 - (a) Pool memberships and utilization
 - (b) Maintenance needs Pump replacement/controls and lifeguard stand. Monica will get quote on lifeguard stands. All the pumps are working. Solar heater is down. Waiting till next year on lifeguard stand.

 - 1. Booked for parties in August so pretty much no night-time swim.
 - 2. Next year if you have a POA sponsored memberships no afterhours keys.

 - (a) Venue rentals and utilization/Discussion on pending refund.
 - (i) Wedding venue price comparison
 - 1. Board needs to look at a price increase for non POA owners. Raising price \$500 and making even numbers. We need to consider an hour day before to do rehearsal. A preference would be to include that in the package or as an option. Day before they usually charge \$100/hr but Heidi suggests charging \$150 flat fee.
 - Kris motioned to voted to increase immediately. October to April increase to \$2500 and May thru September increase to \$3000 for non residents. Resident pricing stays the same. Bitsy seconded.
